This is why we select our suppliers on the basis of clear agreements, we do not use GMO ingredients or raw materials, we have chosen to make organic products that do not contain any sulphites, we pay great attention to the issue of food allergies and carefully monitor the risk of cross contamination clearly indicating on the label every allergenic substance contained in the product, and we believe that compliance with the legal requirements and provisions set out in the relevant legislation and industry standards is a binding minimum requirement.

The commitment and involvement of the whole company and of everybody in the supply chain which we are a part of are essential in order to guarantee to our customers and consumers that the products we make meet the highest quality and safety standards while also protecting the environment.

At ACETUM Spa we take responsibility for providing consumers with reliable information so that they can make informed choices and can consume our products in the knowledge that they are safe to eat. For this reason, we provide clear, detailed information regarding the ingredients the products contain as well as clear information about how to store and use them.

ACETUM Spa strives to continually improve its performance with a view to achieving the right balance between social, environmental and financial responsibility. The performance of the various processes within an integrated management system are measured in order to set new objectives and to be able to adopt new procedures with regards to quality, food safety, environmental choices, and the health and safety of all the staff working for the company including any contractors, subcontractors and visitors that have dealings with the company.
